

**2009-2010 Orange County Lacrosse Association Waiver Form , Photo Release Form, US Lacrosse
Number Certification Warranty, OCLA Code of Conduct Agreement, Refund and
Inclement Weather Agreements**

1) As a condition of registration and participation, as a parent/coach or volunteer or as minor participant with the OCLA/Newport Ridge Assoc. Leagues, programs, clinics, tournaments, training/conditioning, off site events/special events, to and from afore mentioned activities, or other related activities, I and or we; agree, warrant and covenant the following information: *initial here* ____

2) That as signing this document as parent/coach volunteer, that I am and or we are person (s) over the age of 18 years old and are parent(s) and or legal guardian(s) of minor participant. *Initial here* ____

5) Furthermore, that there might be risks not known, to us or not reasonably foreseeable at this time. *Initial here* ____

6) Assume all foregoing risks, and accept personal responsibility for the damages such as injury, permanent disability or death, as related to minor participant, and I and or we as parent volunteers. Release, waive, discharge, from and any and all liability and covenant not to sue, Newport Ridge Assoc./OCLA Leagues or Teams, and or affiliated clubs, their respective administrators, directors, agents, coaches and or other employees, of the organization, other participants, sponsoring agencies, sponsors, advertiser, and if applicable owner and lessors of the premises, the Newport Ridge Assoc., as owner or lessors, used to conduct the event, all of which are herein after referred to as “*releasees*” from any and all liability in regard to undersigned minor participant and I and or we as parent volunteers. Additionally, the information as ascribed above shall pertain to his or her heirs, and or next of kin for any and all claims, demands, losses, or damages on account of injury, including death, or damage to property, caused or alleged to be caused in whole or part by the negligence of the “*releasees*” or otherwise, in regard to participation by minor participant, and or I and or we as parent/coach volunteers. *Initial here* ____

7) I and or we, parent(s) legal guardians of the minor participant, and or parent/coach volunteer hereby authorize, allow, grant, OCLA/ Teams, and its officers, agents, employees, directors, representatives, treatment as necessary to ensure the well being of the participant, and I and or we as parent volunteers. 8) I and or we, the parents and or legal guardian (s) of minor participant; warranty, covenant, and agree that I and or we have read the Minor Waiver, and or as Parent /Coach Volunteer Form, and agree to all its stipulations, conditions, and restrictions and understand that I and or we have given up substantial rights by signing it and sign it voluntarily. *Initial here* ____

9) I and or we, as either the parents (s) and or legal guardians (s) of minor participant, agree that by signing this form as either Coach/Volunteer of parent (s) and or legal guardians of minor participant understand that devices for video, photography, filming or other devices for reprographic images may be used on the field, for publicity purposes for the exclusive use to promote the OCLA and or its affiliates and that notices for such devices and or filming may not be posted. Further more agree that the OCLA and its affiliates, has the right to use such images for their exclusive use and for the perpetuity of these images and that participants will receive no specified compensation for these images. *Initial here* ____
